In consideration for allowing my participation in the Red Rock Canyon Marathon, 1/2, & 5K and other valuable consideration, I, the below signed, for myself, my heirs, assigns, executors, next of kin, successors and administrators, intending to be legally bound thereby, hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE Joyce Forier, Calico Racing, LLC; The City of Las Vegas; The City of Henderson; Boulder City; Blue Diamond; The National Park Service; U.S. Department of Agriculture; United States Forest Service; The Bureau of Reclamation; The Bureau of Land Management; Lincoln County; Clark County; The Little A'le'Inn; Katherine Hightower; Performance Health Center; USATF; Red Rock Conservation Area; Nevada Highway Patrol; Nevada Department of Transportation; The United States of America; and The United States Government, its officers, employees, volunteers, and agents, and any and all persons or entities associated with the Red Rock Canyon Marathon, 1/2, & 5K including but not limited to the race promoters, race officials, sponsors, volunteers, involved government entities and all the representatives, successors and assigns of the aforementioned parties from any and all liability, claims, demands, suits, actions and/or causes of action whatsoever for any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, while participating in the Red Rock Canyon Marathon, 1/2, & 5K or arising out of or resulting from my participation in the Red Rock Canyon Marathon, 1/2, & 5K or incurred while in, on or upon the premises/property where the activity is being conducted or in transportation to and from said premises/property, irrespective of WHETHER THE LOSS, DAMAGE, OR INJURY, INCLUDING DEATH WAS CAUSED BY THE NEGLIGENCE OF THE AFOREMENTIONED RELEASED PARTIES, or otherwise. This accident waiver, release of liability and hold harmless agreement shall be construed broadly to provide a release and waiver to the fullest extent permitted by the law. Further, any disputes arising under this contract will be governed by the laws of the State of Nevada and heard before an arbitrator selected by Joyce Forier.
